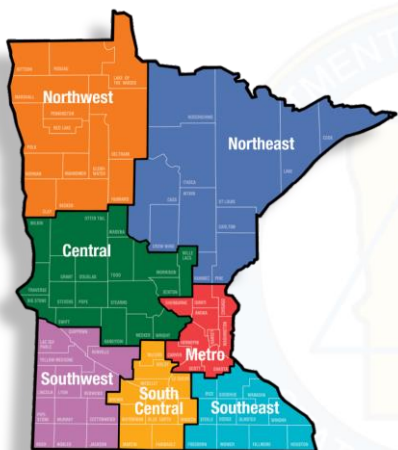

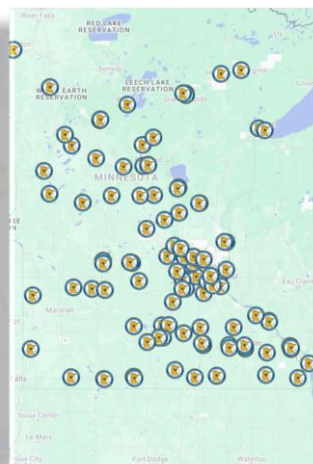

Regions

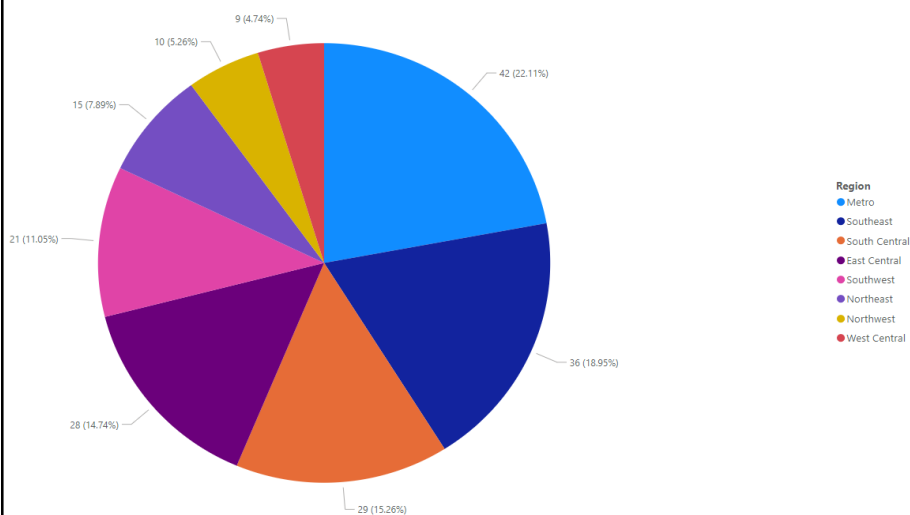


7 RBST Regions

Responsible Beverage Service Training (RBST)

Despite the progress Minnesotans have made in recent years, impaired driving and irresponsible alcohol service continue to be all too common.

Responsible Beverage Service Training is a vital program aimed at promoting responsible alcohol service and reducing alcohol-related harm within local communities.

Purpose: RBST focuses on educating on/off-premises servers of alcoholic beverages and their managers about the risks associated with serving alcohol. It specifically addresses three critical issues:

- **Serving Alcohol to Minors:** Ensuring that alcohol is not served to underage individuals.
- **Over-Serving Patrons:** Preventing excessive alcohol consumption by patrons.
- **Intoxicated individuals:** Recognizing impairment and when/how to cut someone off.

What's covered:

- Laws and ordinances regarding the sale of alcohol.
- The effect of alcohol on the human body.
- Recognition of the signs of impairment.
- Intervention strategies to prevent impaired customers from consuming further alcohol.
- The licensee's policies and guidelines, and the employee's role in observing these policies.
