Regional Seat Belt Survey Rates

The annual, regional observational seat belt survey was not conducted in 2024. Currently, we are taking are reviewing look how the regional observational seat belt checks are completed and are looking to incorporate the regional sites into the statewide survey. However, in Minnesota, we are seeing the statewide annual seat belt compliance steadily increase.

According to the recent annual seat belt survey conducted/funded by the Office of Traffic Safety (OTS) division, more people are buckling up on Minnesota roads. Looking at available survey data dating back to 2010, the 2024 rate of **94.7 percent is the highest rate recorded since 2013 (94.8 percent) and the fourth year in a row we've seen the compliance rate increase.** Increased compliance is demonstrated in populations that have been an ongoing concern, including young adults who are 16-to 29-year-olds and pickup drivers. In addition, the percentage of young adults choosing to wear a seat belt rose to a 10-year high of 93.6 percent. Pickup drivers hit an all-time high of 91.9 percent. We have been working hard to educate Minnesotans on the importance of seat belt safety – and these numbers reflect these efforts.

Regional Successes

- Younger Driver program Impact Teen Drivers
 - Lead Younger Driver State Action Team and implemented the Impact Teen Drivers program statewide in 2023. The education modules include traffic safety from a positive culture perspective and empowers younger drivers and passengers to make good decisions every time they drive or ride in a car. We are fortunate to partner with the Minnesota State Patrol on this initiative as enforcement is key to traffic safety success.
 - To date, TZD NW Region has presented to eight schools with eight more scheduled before year end
 2024. We continue to bring distracted and reckless driving education to over 1,000 young drivers and passengers in our high schools. We have also trained six troopers to help with presentations.
- Completed quarterly reports and annual report for the NW region.
- 2024 Regional Workshop was on April 23, 2024. It was great to have an in-person workshop! We had 81 attendees and 13 exhibitors. The most attended conference ever!
- Engaging younger drivers throughout the region is always energizing! We are always looking for additional ways to empower and impact them!
 - Thief River Falls Lincoln High School partnered with Goodridge High School for the 2023 TTZD Conference on April 10, 2024. The main focus was to bring traffic safety and mental health education to our youth and community.
 - Approximately 300 students and leaders attended. Five area schools participated. Over 120 more than last year!
 - The TTZD Conference is a younger driver traffic safety conference, but it also involves all the E's and is also a venue for a career expo. The 15 breakout sessions and 10 career sessions were presenters from engineering, EMS, enforcement, and education. The students are encouraged to ask whatever questions they have pertaining to these professions. This is the perfect opportunity for students to learn more about all the E's and what career opportunities are out there for them.
 - TTZD has social media posts, Tik Tok videos, and other social media and messaging that they do on a regular basis that focuses on traffic safety.

Northwest Steering Committee

The Northwest TZD steering committee held three meetings this past year. We opted for an "in-person" only meetings in the Spring and Summer and virtual meetings in the Winter. We continue to have roundtable discussions about the region and ask ourselves "who is not at the table and should be?", "how do we engage more of our political, education, and other leaders in our region.

2024 NW Regional Workshop

This past year, the NW region held their workshop on April 23, 2024. We had the highest attendance ever with a whopping 81 attendees and 13 vendor booths. We had phenomenal speakers, good discussions, and overall, a successful workshop.

Regional Seat Belt Efforts

Seat belt use has been a consistent concern in the Northwest region. We continue to bring awareness through education, media, enforcement, and community engagement and events. We utilize the seat belt convincer, seat belt persuader, and driving simulator to educate all ages on the importance of seat belt use. TZD participates in the Safety Around School with SAFE Kids to educate on the importance of buckling up. We also stress buckling up in our Impact Teen Drivers presentations in the high schools. TZD and MnDOT met with LOW County Commissioners at their board meeting at the high school where we shared TZD county and regional data and stressed the importance of wearing seat belts.

Regional Distracted Driving Efforts

We have been utilizing our driving simulator, hands-free and buckle-up stencils, Distract a Match, and TZD banners through outreach events within our communities. We continue to do messaging throughout the communities via digital boards, radio, table tents, enforcement waves, and social media. Distracted driving is one of the key messages that we educate the high school students on in the Impact Teen Drivers curriculum. We also stress the importance of being a good passenger and not distracting the driver in the car.

Regional Impaired Efforts

The TZD equipment has been instrumental in helping with education on impaired driving and has provided an opportunity to build relationships with the regional traffic safety partners. NW TZD has attended various community events, health and wellness fairs, and multiple schools and colleges to educate on impaired and drowsy driving. The driving simulator has impaired driving simulation and has been used in several driver's education classes. Along with the bean bag toss, Jenga, Fatal Vision, Drowsy Goggles, Pedal Karts, and other hand/eye coordination activities to effectively demonstrate how your driving is affected by being impaired. We hope to continue to utilize this equipment to educate and inform that if you feel impaired you drive impaired.

Regional Speed Efforts

Though speed related deaths have decreased since last year, speed continues to be an issue within our region and entire state. In all our education efforts, we continue to stress SLOW DOWN and focus on driving. Extra enforcement, media pleas and messaging and digital boards are a few of the major initiatives to decrease driver behavior.

Other Efforts

Continue to explore all avenues on how to interject TZD into each county in the NW region. We have built a relationship with the NW Regional Development Center and are partnering to bring TZD to counties without a coalition. They are excited to head up the coalition and would like to apply for a Safe Roads Grant in 2024.

I continue to look for creative ways to gain some presence in each county.

• Teen TZD – Younger Driver

- With the statewide implementation of the Impact Teen Drivers program, we hope to bring these educational modules to all the schools in the NW region.
- o I have started a conversation with Leech Lake/Cass Lake High School principal on initiating a Teen TZD in their school. I will continue to keep trying to build a relationship with the tribal communities.
- o Continue to look for opportunities to work with colleges on younger driver safe driving initiatives.
- Continue to work with SRTS grantees in the Northwest area to partner on bike and pedestrian safety efforts, specifically their Safety Around the School initiative.
- Continue to work with SAFE Kids with bike, pedestrian, bus, and car/passenger safety.
- Continue to work with BikeMN / TRF on bicycle safe community initiatives and efforts.
- Continue to work with county commissioner boards to share the TZD message, data, and to encourage TZD efforts in their county.
- Trainings Attended numerous webinars and virtual presentations regarding seat belt usage, speed, distraction, Impaired, safe systems, tribal communities, diversity and equity, and mental health. These are some of the highlights of some of the training webinars that I recently attended:
 - o Teen TZD Conference April 10, 2024
 - o Attended other Regional TZD Workshops to support and learn from the other TZD coordinators.
 - State Action Team planning Continue to build and enhance the Teen TZD State Action team along with Scot Edgeworth. A big win for the State Action Team is the implementation of the Impact Teen Drivers program in 2023.
- Building Relationships both internally and externally by:
 - Participated in local and state meetings regarding all means of road safety and assist by providing educational resources.
 - Attended and participate in TZD regional and leadership meetings, TZD stakeholder Hotdish meetings, TZD statewide calls, D2 leadership calls, WESTAC meetings, and county TZD coalition meetings.
 - o Participate in the Drug-Free Coalition meetings.
 - o Participate in the NW Traffic Advisory Council meetings.
 - Participated in BikeMN Bicycle Friendly Community meetings.
 - o Participate and attend the Western Regional Trauma Advisory (WESTAC) committee.
 - o Participate and attend the Safe Kids Pedestrian and Wheeled Sports committee.
 - Continue to participate in traffic meetings with Red Lake and Leech Lake Tribal communities.

Gaps and Challenges

- Continue to work on recruiting all the E's from every county on the Northwest Steering Committee.
- Finding and building relationships in the tribal communities and bring TZD educational programs to them.
- Getting the buy-in from communities. They are already dealing with staffing issues, so how do we market ourselves to encourage them to partner and give their time, talents, and efforts to start coalitions or work on TZD efforts.
- Marketing and messaging to be quick, fun, eye-catching, and current event specific. Such as concerts in town, Vikings
 games, etc. Can there be a library of messaging to be pushed out within a 24-hour timeframe rather than weeks or
 months.
- Continue to recruit traffic safety partners in counties and communities that TZD does not have a presence.
- Support from political partners such as county commissioners, state, and local representatives.

Media and Outreach Events



Students and advisors at Lincoln High School in Thief River Falls put a lot of time and effort into presenting the Teens Toward Zero Deaths Conference that was held at the Free Church in Thief River Falls on April 10. Over 330 students from throughout the region heard presentations from

several emergency provider organizations. This is the only TTZD Conference held in Minnesota. The goal is to encourage other schools to start their own TTZD organization and to eventually have TTZD conferences throughout the state.

• **East Grand Forks Showcase** – September 4, 2024 - Minnesota State Patrol and TZD partnered to educate on all traffic safety by folks spinning the Traffic Trivia Wheel.





• **Bike Rodeo and Car Seat Clinics** - TZD and partners join forces to educate kids and adults on bike, ped, bus, and car/passenger safety by holding bike rodeos and car seat clinics.





• Central Boiler Corporations Health & Wellness event on September 118 & 19th with community vendors representing all areas of good health which included: medical, chiropractic, rehab, financial, exercise, home, traffic safety, mind, EMS, city police, state patrol, nutrition, and all areas of health of your mind, body, and soul.

Central Boiler employs over 200 employees. The impaired goggles were the big attraction for the employees as they tried to dunk the bean bags while wearing the goggles. The goggles created visual impairment with the level of goggles ranging from just under the legal limit of BAC .07 (.08 is legal limit) to BAC of .25 which would be over three times the legal limit.





• **Tri-Valley EMS Drowsy Driving Training** - August 24, 2024- The pedal kart was used with the distraction goggles to practice tired driving. Each driver relied on their partner to get them thru the cone course...If they hit a cone or the deer they had to change drivers.





• Safety Around the School event – September 18, 2024 - Challenger Elementary School in Thief River Falls. The bike, ped, car/passenger, and bus education is for all students grades kindergarten through 5th grade. We will continue to do this education in several other schools this Fall.





• Impact Teen Drivers Presentation – September 20, 2024 at Kelliher High School. There were approximately 60 students (60% Native American) that attended the presentation "Are You Living In a Dreamworld".





• **Bike TRF Events** - The 3rd Annual Bike TRF Gramble was held on Sept 28, 2024. Biker enthusiasts could ride 1.6, 8, 16, 32, or 64 miles.

It's Getting Hot Out There

Whether you're a parent, grandparent, babysitter or relative, kids are out of school for the summer and may be frequenting your backseat more often for the next couple of months. Although the busy school season comes to a halt in June, your life doesn't slow down as you navigate summer activities and your work schedule. No matter the chaos, always be a responsible driver and care for your passengers.

- Don't forget about them. Life gets busy but don't forget passengers in the backseat. When the temperature hits
 72 degrees outside, a vehicle can reach 117 degrees in just 60 minutes, resulting in heat exhaustion and death in
 some cases. More than half of vehicular heatstroke deaths nationwide occur when a child is forgotten while in a
 rear-facing car seat or sleeping in the backseat. Kids and Car Safety is urging drivers to Look Before You Lock
 during these hot summer days. You can also learn more about vehicular heatstroke and prevention with these
 National Heatstroke Prevention Day resources.
- Teach them to be good passengers. Children can be distracting because they can get restless and start acting
 up. Model good behavior for them, provide mess-free activities to keep them quiet and teach them how to be
 respectful passengers.
- Buckle up, Buttercup! Make a habit of checking your passengers' seat belts before you set out for the
 road. Even if your passengers are close friends, their life is at risk and could cost you a hefty ticket.
- Use a proper car seat. Whether for pets or for children, using a proper seat for their age, height and weight secures your passenger and maximizes safety. Plus, keeping animals restrained decreases distraction in your vehicle!



Minnesota Child Passenger Safety Law Update

Starting Aug. 1, 2024, Minnesota's car seat law is getting a makeover, and parents have plenty to catch up on. The new law states kids must remain rear-facing until a minimum of 2 years old. They must also have outgrown the rear-facing seat by height or weight before switching to a forward-facing car seat with an internal harness.

Every driver who transports a child or children under the age of 18 years in a motor vehicle is required to have the child or children restrained in a child safety seat or seat belt.



Minnesota Child Passenger Safety Law

If a child can be placed in more than one category, then the child must be placed in the more protective category.



An infant under 2 years old must be secured in a rear-facing convertible or infant carrier seat.



A child at least 2 years old AND has outgrown the manufacturer's height or weight limits for a rear facing car seat must be secured in a forward facing car seat with internal harness.



Children at least 4 years old who have outgrown their forward facing car seat with internal harness must be secured by a belt-positioning booster seat using the lap and shoulder belt



A child at least 9 years old or has outgrown their booster seat AND the child can pass the "5 Step Test"

may be restrained by lap and shoulder belt if the child can be secured properly.

A child under I3 years old, must sit in a back seat of a motor vehicle, if a rear seat is available, and be properly restrained.

Drive Sober or Get Pulled Over

"Drive Sober or Get Pulled Over" is an annual enforcement event aimed at preventing impaired driving among motorists and truck drivers. This year, it goes into effect across the country from August 16 to September 2, 2024. During this period, law enforcement agencies step up patrols to identify and apprehend impaired drivers with the goal of raising awareness about the dangers of driving under the influence of alcohol or drugs and encourage responsible behavior on the roads.



Impact Teen Drivers Education

The Impact Teen Drivers Train-the-Trainer training took place at the MnDOT Roseville headquarters on July 25, 2024. The training was for those TZD Coordinators, Minnesota State Troopers, and TZD partners that will be presenting the Impact Teen Drivers educational modules at the high schools. Currently, we have 46 trained ITD facilitators and have presented to 21 schools and 1400 students. Our goal is to build on those 21 schools each year to reach as many 10th grade students as possible each year. The graph below was obtained by the MnDOT safety group, which demonstrates that we are clearly on the right path as to where we need to focus our efforts.

Stop For School Buses

It is hard to believe, but summer is coming to an end for students across the state. With schools welcoming back students, Minnesota school buses will make about 10,000 trips each day. According to the National Highway Traffic Safety Administration, a school bus is one of the safest vehicles on the road for students, but we all need to work together to ensure that everyone makes it home safely.

Stop for School Buses: It's the Law!

- State law requires all vehicles to stop for school buses when the bus driver activates the flashing lights and has the stop arm fully extended.
- Drivers who violate the law face a \$500 fine.
- Drivers can face criminal charges for passing a school bus on the right, passing when a child is outside the bus, or injuring or killing a child.

Motorists:

- On undivided roads, motorists traveling both directions must stop at least 20 feet from a school bus that is displaying red
 flashing lights and an extended stop arm.
- Traffic traveling the opposite direction on a divided roadway with a separating median such as a cement wall or boulevard is not required to stop.
- Motorists should slow down, pay attention and anticipate school children and buses, especially in neighborhoods and school zones.

Students:

- When getting off a bus, look to be sure no cars are passing on the shoulder.
- · Wait for the bus driver to signal that it's safe to cross.
- · When crossing the street to get on the bus or to go home, make eye contact with motorists before proceeding.

You can do your part by knowing the School Bus Stop-Arm Safety law. And students can do their part by keeping themselves safe outside and inside the school bus. Please share with others to ensure that all our children make it home safely. Together, we can move Minnesota toward zero deaths!



Tri-Valley EMS Training

Drowsy driving staff training was held on August 24, 2024 for Tri-Valley EMS. The Toward Zero Deaths pedal kart was used to demonstrate the dangers of drowsy and distracted driving. Each driver relied on their partner to get them thru the cone course. If they hit a cone (or deer) they had to change drivers.





Year-to-Date Traffic Fatality Update

In 2024 through August 25, there were 277 traffic-related deaths on Minnesota roadways. This is 14 percent more than at this time last year (244), 2 percent more than in 2022 (272) and 6 percent less than in 2021 (294). Unbelted fatalities (63) are 31 percent more than this time last year (486), 19 percent higher than in 2022 (53), two less than in 2021 (65) and 50 percent higher than in 2019 (42).

Toward Zero Deaths team created a roundabout to educate kids and adults how to safety cross while walking or riding bicycles. ROCHESTER, Minn. – Sixteen individuals and three organizations were recognized with Minnesota <u>Toward Zero Deaths</u>

<u>Awards</u> at the annual statewide <u>TZD Conference</u> yesterday, for accomplishments that improve safety and reduce the number of life-changing crashes, deaths and serious injuries on Minnesota roads.

The prestigious traffic safety awards are presented by the Minnesota departments of health, public safety and transportation. The TZD traffic safety conference is being held this year at the Mayo Civic Center in Rochester, Minnesota. More than 800 traffic safety professionals registered to attend the conference in-person, or online.



Mission

To move northwest Minnesota toward zero deaths on our roads, using education, enforcement, engineering, and emergency medical and trauma services.

Goal 1 – Reduce TZD Fatality and Serious Injury Goals

To continuously decrease traffic-related fatalities and serious injuries in northwest Minnesota from the past **5-year averages** (2018-2023) of 17 fatalities and 52 serious injuries (preliminary). Note: New injury definitions were introduced in 2016 and may have contributed to a higher reported number of serious injuries.

Objectives

A. To continuously increase regional seatbelt use rates.

The statewide average was 93.3% in 2022. The regional seat belt rate was 86.5% in 2023. No seat belt survey was conducted in 2024. Currently, there is discussion on how to proceed on future seat belt surveys throughout the state. As a region our long-term goal is to achieve 100% usage rate. Our short-term goal is to see continuous increase in the usage rate each year.

- To examine the characteristics of the unbelted fatalities and serious injuries.
 Calculation of seat belt use in fatal and serious crashes is possible with existing data.
- C. To continuously decrease the following:

Region Goal 2 -TZD Partnership Goals

To continuously increase TZD awareness and partnerships across Northwest Minnesota for both the general public and traffic safety professionals

- Establish the vision of NW TZD as a priority for all region, county, city (government agencies)
 - Engage local government involvement in TZD steering committee and workshops.
 - Educate/promote traffic safety awareness of city/county officials.
 - C. Promote City/county employee education/policies that facilitate the TZD vision.

[Activities: Recruitment of city and county to attend TZD event, giving TZD presentations to boards/councils, mailings/connections to Network of Employers for Traffic Safety (NETS)]

- 2. Create and strengthen partnerships in the region.
 - A. Engage stakeholders.
 - B. Develop networking relationships.
 - C. Recruit membership of the TZD partnership.

(Activities: EMS Conference booth/presentation, regional workshop, web, calendar, statistics, workshop, orientation)

- Promote and implement effective traffic safety initiatives in the region.
 - A. Develop and distribute resource materials.
 - B. Provide enforcement wave support in community.
 - C. Promote evidence-based countermeasures.
 - D. Collect data and statistics within region.
 - E. Implement best practices within region.

(Activities: web, brochure, 1-pagers, presentations, news advisories, workshop, seatbelt observational survey and omnibus survey, media messaging and media events, news releases re: activities woven into existing messages, worksite education and policy development, parent component to drivers' education, sober cab development, youth enforcement and education activities)

Region Goal 3 – With implementation of the safe system approach, TZD will integrate services to strengthen EMS capabilities focusing on post-crash care to significantly reduce fatalities.

- 1. Integrate information systems and highway safety activities.
 - a. Fatal and serious injury review committees
 - EMS agencies collect and share pertinent information about the scene including areas such as road
 conditions, environment, contributing elements, interagency communication and other areas that
 impacted the patient and the outcomes.
 - Assist in development of the fatal and serious injury action plan to address and prevent future crashes.
 - Implementation of Traffic Incident Management (TIM) into coalitions and provide TIM training as needed to first responders.



Northwest Minnesota Toward Zero Deaths Regional Strategic Plan

- Public service announcement (PSA) campaign to specifically address the issue of emergency responder safety at crash scenes. Participate in Crash Responder Safety Week in November and throughout the year.
- To advocate for, and promote, National Ambulance Safety and EMS Education Standards, with a focus on post-crash patient transport (adults and pediatric populations).
- e. Partner agencies to integrate post-crash care into the Strategic Highway Safety Plan.

2. Integrate EMS systems into TZD Safe Roads coalitions.

- TZD Safe Roads coalitions will work with EMS on prevention efforts to provide education and outreach to help reduce crashes around the state. EMS can also assist in injury-prevention projects in underserved/diverse areas.
- Assist in action planning with the local coalitions/steering committees.
- Assist with Stop the Bleed (STB) educational initiatives. Provide STB education to communities to include but
 not limited to community organizations, schools, law enforcement, MnDOT <u>Districts</u> and other agencies.

3. Providing timely on-scene care and reduce the time from injury to appropriate trauma level care.

- a. Post-crash care: Trauma-related improvements will help save more lives on the roadways.
 - Auto launch Support the role of air ambulance services as an adjunct to ground ambulance services, especially in rural regions, with documented response time delays.
 - Telemedicine to assist EMS with connection to trauma units. This will support ground ambulance services, especially in rural regions with limited resources. (Pilot project in SC region- Cottonwood, Jackson, Nobles and Rock Counties, SW region – all counties and NE region – all but Pine County.)
 - iii. Sharing of crash data and telemedicine data/results. (Pilot project in SC, SW and NE region)
- * Please note that results involving trauma are a complex issue dependance on volunteers for emergency response, capacity and capabilities of hospitals and trauma centers and other factors can impact the outcomes of traumatic situations. It is our hope that with the use of telemedicine trauma-related improvements will help save more lives on the roadways.
