
MINNESOTA DEATHS TOWARD ZERO DEATHS

Whether you believe it or not, your luck is often contingent on the choices that you make. St. Patrick's Day is one of the biggest days of the year for alcohol consumption and unsafe behaviors such as drinking and driving.

According to NHTSA, there were 290 people killed in alcohol-impaired-driving crashes during the St. Patrick's Day holidays 6 p.m. March 16 – 5:59 a.m. March 18) between 2018-2022. During the 2022 St. Patrick's Day holiday, 74 people died in alcohol-impaired-driving crashes. Drunk male drivers were involved in fatal crashes at a higher rate (29%) during the 2022 St. Patrick's Day holiday compared to female drivers (14%).

Young drivers ages 21-34 accounted for the highest percentage (34%) of alcohol-impaired drivers involved in fatal traffic crashes during the 2022 St. Patrick's Day holiday.

Nighttime driving during the 2022 St. Patrick's Day holiday was significantly more dangerous than daytime driving, with 38% of drivers involved in fatal traffic crashes between the hours of 6 p.m. and 5:59 a.m. being drunk. Almost half (47%) of drivers involved in fatal crashes between the hours of midnight and 2:59 a.m. were drunk.

Make your own good luck and plan a sober ride.

Enforcement Update:

- DWI (optional): March 14-17, 2025—St. Patrick's Day
- Distracted: April 1-30, 2025
- Speed: May 1-Sept 1, 2025 (covers 100 deadliest days)

In 2025 through February 16, there were 33 trafficrelated deaths on Minnesota roadways. This is less than 2019 and 2024, but more than 2020 and 2023. TZD goal is bring fatalities down to 225 by 2025.

Who or What Is TIM?

Traffic incidents are unplanned roadway events that affect or impede the normal flow of traffic. Traffic incidents increase the likelihood of secondary crashes and pose a threat to the safety of incident responders as well as the traveling public. Incidents affect travel reliability, commerce, and transportation system performance. One of the essential responsibilities of transportation and public safety agencies is to ensure the safe and quick clearance of traffic incidents.

Traffic Incident Management (TIM) consists of a planned and coordinated multi-disciplinary process to detect, respond to, and clear traffic incidents so that traffic flow may be restored as safely and quickly as possible. Effective TIM reduces the duration and impacts of traffic incidents; improves the safety of motorists, crash victims, and emergency responders; and reduces the frequency of secondary crashes. TIM is integral to the United States Department of Transportation (USDOT) National Roadway Safety Strategy (NRSS), and is specifically called out as a key element for the post-crash care objective.

The goal for the Federal Highway Administration (FHWA) TIM Program is to continuously improve the safety of responders and road users, the reliability of travel, and the efficiency of incident and emergency response through institutionalization of TIM programs.
